Declaration of Consent for the “Berlin im Rückspiegel” project

The undersigned photographer declares that he/she has taken the photographs submitted as part of the “Berlin im Rückspiegel” project himself/herself and is the sole owner of all rights to these images. By submitting the photographs to KPM Hotel & Residences GmbH / KPM Königliche Porzellan-Manufaktur Berlin GmbH (hereinafter jointly referred to as the “Organisers”), he/she grants the Organisers the transferable and exclusive right of use, unrestricted in terms of time, place and content, to all submitted images. The granting of rights includes the use of the photographs within the scope of the project, its public presentations and all accompanying activities, in particular their use for exhibition, documentation, press and advertising purposes in all known media formats, including print and online media as well as social networks, as well as their use in project-related publications such as books, catalogues or other publications.

The right of use expressly includes the right to edit and modify the photographs, in particular to crop them, adjust their colours, combine them with text, graphic elements or layouts, and integrate them into print and digital products. The photographer also permits the transfer of the images to third parties involved in the project or related public relations work, in particular to media partners, press representatives, agencies, service providers, printers and publishers, and agrees that sublicences may be granted to them.

The use of the photographs is entirely free of charge. The photographer waives all claims to remuneration, including those under Sections 32 and 36 of the German Copyright Act (UrhG). The claim under Section 32a of the German Copyright Act (UrhG) remains unaffected, insofar as such a claim cannot be excluded by law.

The photographer agrees to be named as the author but makes no claim to this. The organisers shall decide at their own discretion whether and in what form a name is to be credited. Any such crediting may take place, in particular, in the context of the image, in image credits, in the legal notice or in other project-related accompanying materials.

The photographer warrants that the use of the photographs does not infringe any third-party rights. In particular, he/she confirms that the persons depicted have given their valid consent and that all consents required for publication have been obtained. The photographer further warrants that no third-party personality rights, copyright, trademark rights or property rights stand in the way. He/she indemnifies the organisers against all claims that may arise from any infringing use of the photographs and undertakes to compensate for all damages and costs incurred in this context, in particular in the event of infringements of personality rights and trademark rights.

The organisers process the personal data recognisable in the photographs exclusively for the purposes of implementing, documenting and publicly presenting the ‘Berlin im Rückspiegel’ project, as well as for use in exhibitions, publications, press relations, digital media and social networks. The data controllers are KPM Hotel & Residences GmbH and KPM Königliche Porzellan-Manufaktur Berlin GmbH. The data will be passed on to service providers acting for the aforementioned purposes. A withdrawal of consent shall apply exclusively to the future; materials already published remain unaffected. In all other respects, the rights under Art. 15 et seq. of the GDPR apply
